<b>Accident/Injury Report</b>	<ul style="list-style-type: none"> <li>The committee reviewed the June 2022 Accident &amp; Incident Summary Report.</li> </ul>	<ul style="list-style-type: none"> <li>There was a question about if CPFM employees who are injured while working with Housing are listed as CPFM or Housing on the report. Haily shared that the injured employees are listed by their department, regardless of where the injury may have occurred.</li> <li>There was a question about a head injury that was listed as a concussion. Haily confirmed that the employee did receive medical attention for concussion.</li> </ul>

		<ul style="list-style-type: none"> <li>There was a question about an employee's sensitivity to a bag liner. Haily shared that the liners have been removed from service until further notice.</li> <li>There was a question about a strain/sprain injury to a custodian. The recommendation was to 'empty bag earlier.' If this is not possible, Haily shared a technique that she learned from Ruby when following up on the injury. The technique calls for a custodian to tie off their bag, then open a new bag and place it on top of the other bag to collect more trash. When it comes time to take the bags to the dumpster, they will have 2 lighter bags instead of 1 heavy bag to put in the dumpster.</li> <li>There was a question about cut gloves. Haily explained that they are a glove that will not prevent cuts, but are good for reducing the severity of cuts. They generally have a Kevlar or similar cut resistant fabric woven into the glove.</li> </ul>
